

What is the European Stock Exchange?

Almost 100,000 companies and projects have been successfully funded using crowdfunding equity and debt-based platforms in the past 5 years.

But what then?

After crowdfunding where does a company go for:

Another round of financing?

A structured exit strategy?

More sophisticated investors?

Expert help?

Access to capital markets?

A listing on a regulated stock exchange?

The European Stock Exchange is unique.

It's the bridge between crowd funding and a regulated exchange where companies can get access to financing and support from collaborators & executives, and investors can get access to exciting companies while they build themselves up.



That's Right. The European Stock Exchange is an exchange that doesn't trade stock.

So what does that mean?

ESE registered investors buy stock direct from **ESE** listed companies but no investor-to-investor platform exists. Investors are therefore investors who believe in the company and offer long-term support rather than traders for whom the stock is just a commodity to be bought and sold.

This is crucial in protecting these fledging companies from destabilizing influences on their stock price while they gain experience and strengthen their business without the regulatory burden.

For the investor this protects the value of their investment. **ESE** registered investors buy shares in our **ESE** listed companies via Crest. The value of these shares as can be seen as Quoted Private Equity and the investor can feel safe in the knowledge that trader mentality cannot affect the value of the investment as it may on a regulated exchange.

- All investors must register with **ESE** & Anti Money Laundering and other checks are made by **ESE** and its partners to ensure they meet the criteria to invest in your firm
- Communications with investors via **ESE** website or direct
- Any funds raised are paid directly to your company, not held by **ESE**. (Although our partner registrar may provide escrow in some circumstances)
- General information on common structures for financing as well as more bespoke ideas are published on the site. No fees are charged by **ESE** when funding is raised and no advice given regarding any particular investment.

- Full registrar services for easy confirmation of shareholding and issuance of certificates or CREST transfers.
- Full company secretarial support ensuring company properly constituted for investment and all statutory documents, resolutions and filings are in place
- Payment of investment direct to company (Or via escrow under some circumstances)

Stock exchange Seats.

This is an old tradition brought back to life by **ESE**. A small number of seats are available on The European Stock Exchange for Private Equity Funds who have multiple investments in companies they may want to list on **ESE**. This provides a trading platform for PE Firms to find new deals, participate in a larger number of deals and as partial or complete exit strategies in the future.

These seats allow owners access to deal flow first; by getting information on companies before the listing is complete (like a pre IPO) 5 free listings per annum for staged exit strategies and discounts on additional listings.

We believe these seats will give rise to a greater number of investment as well as spreading risk and providing vital "mass' feedback on their deals. This values the seat itself as a solid investment for any Private Equity Fund with an eye on the future.
